

About Canadian Criminal Records Check – National Level

Area Searched National/all Provinces (major and minor offenses).

Source Law enforcement.

Search Period Varies, generally 5 business days.

Content Limited – Standard National Level search results are limited to “**RECORD**” or **NO RECORD**” as of a government decision. Normal case data such as type of charge, case number(s), etc. are currently unavailable to third parties (other than the applicant). Subjects may access their own records at any Canadian police station by completing an application and submitting to fingerprinting.

Authorization Required signed release. Specific release form available in QuickScreen Landing Page.

Documentation Required Signed Release & 2 forms of ID that include name and DOB, one must be a photo ID, uploaded in QuickScreen prior to Origen ordering the Canadian BG search.
